District-wise Empanelment of Videographers/Stringers for Videography Services

Video Communication Division of C-DIT, Thiruvananthapuram invites online application for empanelment of videographers/stringers with experience in video shooting.

Stringers are required in all 14 districts. Applicants should mention the districts for which they wish to be empaneled in the application form.

Empaneled Stringers/Videographers are expected to do video documentations/short videos/documentary shooting, etc. as per the requirements of C-DIT. Videographers/Stringers should have adequate facilities and equipment's to undertake the video shooting, Those equipped with 4 wheel vehicles will be preferred. Proof of ownership of the equipment's must be submitted at the time of interview. A physical verification of the equipment's and documents will be done at the time of interview. The selected videographers/stringers shall execute an agreement with C-DIT detailing the service.

The applicants should submit application on or before 10th November 2022, 5 PM to reach the following address:

Application received after the closing date & time will not be accepted in any case.

- i) Applicants equipped with videography equipments (HD Camera supporting format 3840 x 2160 / 1920 x 1080) having 4-wheeler vehicles and possessing qualification and experience and expertise in Cinematography/Videography.
- ii) Videographers/Stringers will be paid for video shootings irrespective of length of footage. The rate will be inclusive of transportation and delivery charges.

- iii) Local coverage of duration of 6 hrs. @ Rs.5,500/- per coverage and in case of duration exceeding 6 hrs. or in case it involves multiple location with a distance of more than 10 kms, additional Rs.1,500/- will be paid as transportation charges.
- iv) In case of outstation shooting, which are coverages undertaken beyond geographical limit of the town (high range/hilly/off-road areas). The charges for coverage will be Rs.8,500/-.
- v) For each coverage the Videographer/Stringer should provide raw footage, log sheet, press materials if any and the footages shall be delivered immediately after the shoot via online sharing **platforms**.

Videographers/Stringers will be removed from the panel for any of the following grounds:

- 1) If the Videographers/Stringers refuses to cover the video shooting assigned to them for two or more occasions.
- 2) If the video shooting output is poorly shot or is in poor technical quality, poor audio/video quality, noisy video, variation in luminance level, defocused picture, etc.
- 3) Delay in providing the video footages as per the requirement.
- 4) If the Stringer is sub-contracting the assigned works to others.
- 5) Any act on the part of the Stringer/Videographer which creates difficulties to C-DIT or its associated partners.
- 6) If the footage is found used for projects other than C-DIT

Empanelment will be based on scrutiny of applications and personal interview. C-DIT reserves the right to short-list a few of the applicants for the interview, based on the selection criteria.

Selected candidates shall enter into an agreement with C-DIT. Empanelment will be for a period of 2 years and may be extended further on mutual agreement if so required by C-DIT.
