2. ELIGIBILITY CRITERIA OF TENDERER

Only those firms which in their individual capacity, satisfy the following criteria, need to quote for this tender.

1. To qualify for award of the order, the intending bidder must be an supplier of the quoted items with prior experience in supplying the same or similar equipment.
2. The bidders will be responsible for effecting supply to the entire satisfaction of the undersigned or his authorized representatives. In case any defect in the item supplied is noticed, such item will be rejected at the risk and cost of the Supplier.
3. Bidders should have valid GST registration.
4. Bidders should have PAN allotted to him by the IT Department
5. Bidder shall not be blacklisted by any government agencies.

4. OTHER TERMS AND CONDITIONS

2. advance payment will be made against supplies.

3. **The rate quoted by the bidder shall be inclusive of all applicable taxes, transportation charges and delivery charges at site.** Rates quoted by the bidder shall be valid for a period of six months from the date of opening of the tender.

4. Delivery period shall be specifically indicated in the tender and strictly adhered to. The supply shall be arranged within **10 days** on receipt of the firm order. Any delay in the delivery period after the supply order is placed may result in cancellation of the supply order or payment of liquidated damages @ ½% per day subject to a maximum of 10% of contract price.

5. The rate should be quoted for the unit shown in the list and tenders which do not indicate this essential information will not be considered.

6. The rate quoted for material shall be firm and no enhancement will be allowed under any circumstances.

7. The Supplier/ Contractor shall provide comprehensive warranty of **one year** for the products from the date of supply.

8. If the bidder furnishes wrong and/or misleading data, statement(s) etc. about technical acceptability of the goods and services offered by it, its tender will be liable to be ignored and rejected in addition to other remedies available to the purchaser in this regard.

9. Items offered shall conform in all respects to the relevant Indian standard Specification.

10. Any dispute / differences between the parties arising out of and in connection with the contract shall be settled amicably by mutual negotiations. Unresolved disputes/ differences, if any, shall be settled by Arbitration and the arbitration proceedings shall be conducted at Thiruvananthapuram (India) in English language, under the Indian Arbitration and Conciliation Act(Amended), 2013. Unsettled disputes will be referred to courts and courts in Thiruvananthapuram/ Kerala will have exclusive jurisdiction over the same.
