S. R. O. No. 467/2017.—In exercise of the powers conferred by clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Kerala hereby makes the following rules further to amend the Rules of Business of the Government of Kerala, namely:—

RULES

1. *Short title and commencement.*—(1) These Rules may be called the Rules of Business of the Government of Kerala (Amendment) Rules, 2017.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Rules of Business of the Government of Kerala, in Part II, in the FIRST SCHEDULE, under the heading DISTRIBUTION OF BUSINESS AMONG DEPARTMENTS OF THE SECRETARIAT,—

(i) under the sub-heading ‘IX. ELECTRONICS AND INFORMATION TECHNOLOGY DEPARTMENT’, after serial number 12 and the entry against it, the following serial number and entry shall, respectively, be inserted, namely:—

“13. The Centre for Development of Imaging Technology (C-DIT).”;

(ii) under the sub-heading ‘XV. GENERAL ADMINISTRATION DEPARTMENT’, under item ‘H. Information and Public Relations’, serial number 14 and the entry against it shall be omitted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Centre for Development of Imaging Technology was set up under the Travancore Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 (XII of 1955) to tap the emerging technological possibilities in imaging technology and related matters. When the Centre for Development of Imaging Technology was started, it was under the Cultural Affairs Department. As per notification issued under G. O. (Ms.) No. 462/2005/GAD dated 20th December, 2005 and published as S. R. O. No. 1102/2005 in the Kerala Gazette Extraordinary No. 2755 dated 21st December, 2005, the subject “The Centre for Development of Imaging Technology (C-DIT)” was included under item “H. Information and Public Relations” under the General Administration Department. But, considering the predominant experience and expertise of C-DIT and the nature of its

functioning and taking into account its potential in playing an important role in e-Governance and other emerging areas of Information Technology, the Government have decided to transfer the subject "The Centre for Development of Imaging Technology (C-DIT)" to the Electronics and Information Technology Department. Hence, the Government have decided to amend the Rules of Business of the Government of Kerala for the above said purpose.

The notification is intended to achieve the above object.
